LOCATION

The town of Haddington is the main administrative centre for East Lothian lying circa 17 miles east of Edinburgh. The town serves the immediate population together with a number of surrounding villages. Haddington benefits from immediate access onto the A1. A number of new housing developments have increased the town's population to around 12,000, however, more new homes are planned thereby increasing the population further.

The subjects are situated on the north side of the High Street on the corner of Mark Lane, which is a busy link between the High Street and Market Street to the north. Surrounding occupiers include Boots the Chemist, Subway, Semi-Chem, Cancer Research and Black + Lizars.

DESCRIPTION

The subjects comprise an attractive retail unit forming part of a traditional stone built tenement. Internally the accommodation comprises ground floor sales and staff accommodation of circa 46 sq m (498 sq ft). Unused basement accommodation would allow future expansion.
