LOCATION

The subjects are situated on Drem Road (B1377) which links Longniddry with Drem, Aberlady, Dirleton and North Berwick to the east. Longniddry Train Station lies to the west at the junction of Main Street (A198).

Longniddry is a popular commuter village lying some 15 miles east of Edinburgh. The resident population is circa 2,500. However, this is set to increase following a number of new housing developments, particularly at the Longniddry Village development with some additional 450 new homes planned. Surrounding villages and towns in East Lothian have all seen new housing developments.
