LOCATION

Kirkcaldy has an estimated population of some 50,000 making it the second largest centre in Fife, only marginally smaller than the City of Dunfermline.

The subjects are situated on Whytehouse Avenue close to its junction with the High Street. Whytehouse Avenue is an established retail destination with surrounding occupiers including the Migele Experience, CC Floral Design and Two Sons Tattoo. Jock’s Bar & Grill and Charles Clinkard Shoes are situated on the corner of the High Street.

DESCRIPTION

The subjects comprise a single windowed ground floor retail unit previously used as a hairdressers.



